C.M. Russell Museum Image Use and Reproductions Conditions

1. REQUESTS to reproduce an image owned by the C.M. Russell Museum for publication *must* be made in writing using the Museum's Image Request form. Once permission is granted for use, applicable fees are payable in advance, whether or not the image is used. The Museum reserves the right to deny any request for publication or commercial use of an image in order to protect the legacy of the artist in question and to ensure that his or her work is fairly and tastefully represented. All requests for permission to reproduce an image for publication must include the intended use, the publisher, and expected date of publication.

2. PERMISSION to reproduce is limited to one-time use only, in one edition and in one language. Additional language editions, subsequent editions, and any related promotional use must be considered as separate requests and will require additional fees and a new written application. Exclusive rights are not granted to any publisher. Photographic materials may not be used for any purpose other than that listed on the permission form, nor may they be assigned to any other person or firm. The Museum reserves the right to decline to provide photo reproductions to applicants who have not complied with its policies or whose products are unacceptable to the Museum for any reason. Applicant agrees to take all due care to protect the materials from unauthorized use by any person or entity.

The curatorial staff of the Museum in its sole discretion reserves the right to refuse permission if in its opinion the application is not appropriate for the collection or if acceptable standards of reproduction and care of the Museum's objects have not been obtained.

3. CROPPING or masking out is not allowed on the painted area of a picture, the outline of a sculpture or object, and the area within the white border of a photograph or a graphic work, including inscriptions. Permission may be negotiated on an individual basis for cropping of works or using a detail, provided that the work in its entirety appears elsewhere in the same publication. The word "detail" must appear in the caption with the complete credit line.

4. BLEEDS - Reproductions may not run off the edge of the paper without written permission and approval of proof prior to publication.

5. OVERPRINTING - Reproductions may not be superimposed with type matter or in any way defaced or altered.

6. COLORED STOCK - Reproductions may not be printed on colored stock.

7. DIGITAL OR ELECTRONIC IMAGE – Images are on a one-time use only basis, unless otherwise specified. Use in electronic media is considered on a case-by-case basis. The client is licensed to store the images in his digital database for the duration of this agreement only.

The following terms and conditions apply to electronic publication and web use:

Images will be limited to no larger than half-screen size and will be embedded for viewing purposes only. It is recommended that the site and product(s) also include a general copyright warning regarding intellectual property included therein.

The producer/publisher accepts full liability for infringement of the copyright material due to non-conformance with terms above.

8. COVER USE- Permission for book jacket, video or calendar covers will only be considered upon receipt of a cover design.

9. CREDIT LINE - The credit line must include *artist, title, date, medium, and: C.M. Russell Museum, Great Falls, Montana*, unless specifically noted otherwise on contract. It must appear next to the reproduction or in an appropriate portion of the publication.

10. SPECIAL PROJECTS - Reproduction in Advertising, or in a Promotional Context, or as an Integral Part of the Commercial Product. Application to reproduce works of art in these categories will be discussed with the Museum Shop director, and a fee schedule will be determined either via payment of a one-time reproduction fee, and/or a negotiation of a contract for royalty payments to the Museum. If the Museum Shop wishes to distribute the commercial product, the Applicant may be required to deposit a number of free copies for re-sale in the Museum Shop as part of the negotiated reproduction fee or royalty contract.

11. PROOFS - For color reproductions, color proofs must be submitted and approved by the Museum before printing. Failure to comply with the corrections indicated on the submitted proof may result in the withdrawal of approval.

12. INDEPENDENT USE - The C.M. Russell Museum does not supply images to companies or individuals operating a photography retail and/or sales service.

13. COMPLIMENTARY COPY - The publisher is to provide **a complimentary copy** of the publication or production in which the image is reproduced. In the case of a MA thesis and Ph.D. dissertation, photocopies of the references to the illustration will be acceptable. In the case of primary and secondary level textbooks, tear sheets of the page on which the image is reproduced, as well as the entire article in which the image is used and the credit line is given will be acceptable.

14. DISCLAIMER - The C.M. Russell Museum assumes no responsibility for any royalties claimed by the artist or on his/her behalf or on the behalf of his/her estate. In the case of works by living artists or other copyrighted material, the applicant must supply written permission from the artist or the artist's agent. The user must assume all responsibility for question of copyright that may arise in the use of reproduced material. Responsibility for researching outside copyright, including copyright pertaining to the works of deceased artists, falls to the applicant.

The Museum makes no warranties or representations and assumes no responsibility whatsoever for any claims against applicant or the Museum by the artists, their agents, estates, or by any parties in connection with the reproduction of works of art in the collections of the Museum. The applicant agrees to indemnify the Museum and hold it harmless against any and all such claims, including copyright infringement claims, royalty or fee demands and/or actions, including the costs thereof arising as a result of the applicant's reproduction of the works of art in the Museum. Outside parties hold copyrights to many of the works in the Museum. Any and all royalty payments or other requirements specified by the copyright owner of such a work must be paid or honored by the publisher or agent requesting reproduction permission. **In the case of living artists, the applicant must deliver the artist's permission in writing before the Museum will release any photographic material.**
